#### Notable Work

Boutique Manager of Bowery Hotel: When the owner of a new, luxury hotel in the Bowery neighborhood of Manhattan used the pandemic to remove the hotel manager and convert the property into a homeless shelter, Josh successfully prosecuted the hotel manager's wrongful termination claims in an expedited proceeding before the International Chamber of Commerce, which awarded the hotel manager over \$10 million in damages, as well as injunctive relief barring the owner from continuing to use the hotel manager's trademarks.

Asset Purchase of Boutique Hotel Company: Represented a family-owned and operated nationwide, boutique hotel company in its acquisition by a global hotel conglomerate for nearly half a billion dollars. Josh advised the client of the litigation risks associated with the transaction, as well as developing the acquisition structure that was implemented to avoid triggering certain default and termination provisions in the client's myriad hotel management agreements, which would have devalued the purchase price of the acquisition.

**Professional Sports Team**: Represent a professional sports franchise in connection with the assertion of professional errors and omissions claims against the architect and construction manager retained to build the franchise's new stadium.

Eden Roc Hotel: Represent the owner of the Eden Roc hotel in Miami Beach in (i) asserting claims against Marriott International and its subsidiaries for mismanaging the hotel; and (ii) securing the vacatur of a preliminary injunction that had required the owner to permit the hotel management company to continue to manage all hotel operations against the owner's will, by successfully arguing that injunction inappropriately compelled performance of a personal services contract.

World Trade Center Litigation: Represented net lessees of the World Trade Center after 9/11 in a three-month trial and formal appraisal hearings concerning insurance coverage and the amount of the loss.

Summary Judgment Against The Gap, Inc.: Represented the owner of a 35,000 square foot corner retail unit on Lexington Avenue in enforcing its lease against The Gap, Inc., who made a corporate-wide decision to stop paying all rent in the face of the COVID-19 pandemic. In a first of its kind decision, the District Court of the Southern District of New York rejected the Gap's *force majeure* defense, holding Gap liable for holdover rent under the Lease.

Real Estate Investment Fraud: Successfully defended a large real estate owner and investor in Class A office and retail properties throughout the country in an expedited international arbitration brought by a group of "family and friends" investors claiming their investments were induced through a complex fraud and seeking rescission of their multi-million dollar investments. Not only was the case dismissed after an expedited, International Centre for Dispute Resolution arbitration hearing, but Josh's client was awarded all of its attorneys' fees incurred in defending the action.
