

## Notable Work

Opposing Application for Discovery Under 28 U.S.C. § 1782: Secured a major victory for our client, a Chilean company, that sold its interest to a Chinese company for \$1 billion. The purchaser of the company filed various actions in different jurisdictions claiming that the seller defrauded the buyer by overstating the value of the company. The purchaser was trying to undo the sale claiming fraud and improper administration, amongst other allegations. Therefore, the purchaser filed a § 1782 application to seek discovery in the United States District Court for the Southern District of Florida to seek discovery from our client related to the sale. We intervened in the action and successfully opposed the application.
