# Akerman's Ashlea Edwards Named President-Elect Designate of The Florida Bar Young Lawyers Division

She will preside over all regular meetings of the YLD, serve on The Florida Bar Board of Governors, and act as an advocate for Florida's young lawyers to accomplish the goals of The Florida Bar.
