He also helped shepherd the \$120 million sale of the oceanfront land and, most significantly, he was responsible for guiding compensation of the victims and homeowners of Surfside, based on a \$1.1 billion settlement that came from the developers, engineering consultants, and security companies whose errors may have caused the disaster, as well as their insurers.
