## Notable Work

**Precedent-Setting Victory in District and Appellate Courts**: In a recent federal court victory, led a team that not only created federal precedent but prevailed before some of our region's most well-regarded jurists: the then-presiding Chief Magistrate for the U.S. District Court of the Southern District of Florida, who granted a pivotal discovery motion argued by Valerie; the Chief Judge for the U.S. District Court of the Southern District of Florida, who entered several favorable orders including the summary judgment motion authored by Valerie; and the Chief Judge of the 11<sup>th</sup>Circuit Court of

Appeal, who penned the appellate decision affirming that summary judgment.

**Product Liability/Multi-District Litigation Involving International Parties**: Lead counsel in managing a 15-lawyer team defending homebuilders in more than 130 claims in federal multi-district and federal and state court litigation involving allegations of use of defective Chinese drywall causing construction problems and personal injury. Utilizing an aggressive defense, including filing third-party suits and cross-claims against other entities in the manufacture and supply chain, achieved a successful resolution with minimal exposure for the clients.

**Consumer and Privacy Litigation**: Defended a major airline in two federal class actions alleging violations of the Fair and Accurate Credit Transactions Act stemming from a computer programming error by an outside vendor. Litigation resolved on terms favorable to client following a second mediation, which involved multiple insurers that agreed to participate and extend coverage for class settlement only after prompting by defense counsel.

**High-Stakes Insurance Litigation**: Successfully defend national and regional insurance companies, medical product manufacturers, selfinsureds and asbestos settlement trusts in more than 75 federal and state cases, many putative class actions, from Miami to Los Angeles involving allegations of failure to properly reimburse private Medicare Advantage or Medicaid plans and related entities for payments made for medical treatment of Medicare or Medicaid beneficiaries.
