Megan to counsel internationally based companies seeking to expand operations in the United States on best practices for businesses, how to avoid litigation, and how to handle disputes when they arise.

Megan devotes her community and philanthropic work to mentorship and education. She serves as a director for Elevate Orlando, a nonprofit organization providing life skills training in the public school system and after school mentoring. As a member of the United Negro College Fund's Advisory Board, she pioneered a STEM pipeline scholarship and internship program in partnership with the United Negro College Fund, which honored her with its Champion of Education Award. Megan was also recognized as a "Best Mentor" in *Corporate Counsel's* 2022 Women, Influence and Power in Law Awards.

### Notable Work

#### **Precedent-Setting Ruling in Florida Condominium Litigation:**

Litigated first contested and reported judicial termination of a condominium in the State of Florida. Given the novelty of issues litigated through this proceeding, Megan consults on high stakes condominium terminations throughout the State. *Unicorp Colony Units, LLC v. Colony Beach & Tennis Club Ass'n, Inc.*, 2019 WL 4419074 (Fla. 12th Cir. Ct. Sarasota Sept. 6, 2019).

**Appellate Litigation:** Secured reversal of trial court order denying client's motion to dismiss on personal jurisdiction grounds in a \$40 million products liability claim by successfully arguing the application and interpretation of the jurisdictional requirements of Florida's long-arm statute. *ProAmpac Holdings, Inc. v. RCBA Nutraceuticals, LLC*, No. 5D21-2019 (Fla. Dist. Ct. App. Sep. 2, 2022).

**Appellate Litigation:** Secured reversal of trial court order on due process grounds. *Winthrop v. Castellano*, Case No. 5D12-4759 (Fla. 5th DCA, April 17, 2013).

**Appellate Litigation:** Secured precedent-setting ruling outlining attorney's ethical obligations upon receipt of confidential information and affirming disqualification of an opposing law firm which obtained the client's confidential, attorney-client communications from the opposing party. *Castellano v. Winthrop*, 2010 WL 322177 (Fla. 5th DCA).

**Commercial Litigation:** Successfully represented industrial packaging and products supplier, in breach of contract and business torts action, by arguing the interpretation of the jurisdictional requirements of Florida's long-arm statute when at the time there were not many published court opinions on the issue.

**Commercial Litigation:** Obtained dismissal, with prejudice, on initial Motion to Dismiss, on behalf of a global flexible packaging company in a \$40 million commercial product liability case in the Eastern District of Wisconsin. *RCBA Nutraceuticals LLC v. Proampac Holdings Inc.*, No. 23-CV-305 (E.D. Wis. Jun. 29, 2023).

**Commercial Litigation:** Represented a Fortune 500 company in shareholder derivative class action. Representation involved coordination and roll-out of sensitive and extensive e-discovery as part of an accelerated proceeding.

**Commercial Litigation:** Represented a limited liability company and manager member in multimillion dollar dispute involving claims of

misappropriation, breach of fiduciary duty, judicial dissolution and other business torts through trial and subsequent appeals.

**Commercial Litigation:** Represented a large consortium of international clients to protect, maintain, and preserve millions of dollars in investment assets in the United States.

**Multi-District Construction Litigation:** Represent national homebuilders in high-volume, multijurisdictional disputes involving construction defect claims brought by purchasers.
