drafting of land use regulations and facilitating the adoption of the NRD-1 legislation. This included the creation of a parking trust fund and localized public benefits fund to generate investment in Wynwood's public realm through private sector contributions. Akerman's work was spearheaded by Partner Steven Wernick, and included Associate Nicholas Barshel and Urban Planner Maeve Desmond.
