West Palm Beach Women lawyers applying to the program must have at least three years of experience, possess excellent credentials and a strong desire to return to and advance in a law firm. The fellowship commitment is no less than one year. Participant law firms are expected to assign selected fellows high-level, complex work commensurate with their experience and training to help ease them back into practice.
