In addition to his fraud and recovery practice, Eddy advises clients on the legal and regulatory aspects of their commercial and transactional opportunities. Securities Fraud: Receiver over an \$82 million securities fraud involving the sale of fractionalized life settlements and their derivatives. The assets' liquidation value was approximately \$0.40 per dollar invested. We reorganized the assets increasing the expected net distributable cash to \$1.00 per dollar.

EB-5 Fraud: Receiver over an \$13 million securities fraud arising out of material misrepresentations made by an EB-5 Regional Center and its affiliated entities.

Ancillary Receivership: Ancillary receiver to a Washington State receiver in connection with the liquidation of a 137 acre tract of land in Harris County, Texas.
