### Notable Work

**Legal Malpractice Litigation:** Represented a law firm and some of their individual partners as co-lead counsel in a two-plus week jury trial and secured a complete defense verdict for our client.

**Legal Malpractice Litigation:** Represented a law firm defending a malpractice action arising from adverse outcome in patent litigation.
