### Notable Work

**Commercial Dispute:** Plaintiff alleged that our client breached a contract, which caused a potential buyer to back out of purchasing the plaintiff, and sought more than \$70 million. We obtained a favorable result in a motion for summary judgment where the court found that our client had no liability and also granted our client's counter-claims against the plaintiff.

**Compelling Arbitration:** Assisted in the representation of bringing a petition/motion to compel to arbitrate the parties' dispute in California. The trial court issued an order denying the motion to compel arbitration; a reversal from the Florida Fifth District Court of Appeal found that the trial court erred in denying the petition/motion to compel arbitration on the apparent basis that it lacked jurisdiction or legal authority to consider the merits because the arbitration would be conducted in California and would not apply Florida law.

**Tort Litigation:** Assisted in representing national retail and restaurant clients in a variety of complex tort litigation including premises liability, products liability, and negligent security matters.

**Class Action Defense:** Assisted in the class action defense of one of the largest equipment rental companies in North America in a multi-state class action instituted by corporate customers alleging excessive transportation and fuel surcharges.
