- Representation of a large community college in contentious labor negotiations where the client was able to avoid a strike through creatively resolving a health insurance issue that was at the center of the conflict.
- Representation of a religiously affiliated college against a union that was trying to organize contingent faculty (adjunct and nontenure track employees). By proving to the NLRB that the college was exempt from its jurisdiction as a religious educational institution, the union ultimately withdrew their petition on the day of the representation hearing rather than litigate the issue.
