Akerman Sponsors 26th Annual New York State Affordable Housing Conference May 15, 2025 This project involved conceptualizing and obtaining approval of a new interpretation of an available real estate tax abatement program to enable a substantial benefit on a portion of the building. Approvals for this complex incentive package were complicated by the existing landmarked status of the mid-town Manhattan building above which a new high rise tower was constructed. Continued incentives compliance representation is ongoing.

Multiple Competitive Funding Round Awards: Represented a private developer on a transformative multi-phase, mixed use, urban redevelopment project in downtown Yonkers, New York. Acting as a strategic development resource charged with spearheading the acquisition of the project's incentives package, multi-year State grant awards totaling \$3.5 million were secured in competitive funding rounds. Furthermore, Yonkers Industrial Development Agency benefits included meaningful bottom line benefits including mortgage recording tax abatement, sales tax exemption of construction materials, and Payment in Lieu of Taxes or PILOT benefits.
