

Bankruptcy Appeals: Represents numerous parties in connection with complex bankruptcy appeals that are currently pending.

Complex Chapter 11 Bankruptcies: Represented principal secured creditor with over \$100 million in claims in six related Chapter 11 bankruptcy matters in the Bankruptcy Court for the District of Puerto Rico. Secured dismissal of four of the six cases and obtained relief from the automatic stay and order excusing the turnover of assets by the receiver on the remaining two cases, which involved a large subdivision and apartment complex. The creditor eventually caused the sale of the subdivision through a 363 sale and foreclosed on the condominium complex.
