## Notable Work

Many of Bill Heller's matters are confidential or not otherwise authorized for marketing use. These public matters are a small sampling of his representative work:

- Plaintiff, for himself and other similarly situated Florida borrowers, alleged PennyMac violated the Florida Consumer Collection Practices Act, Fla. Stat. § 559.55, *et seq.*, breached the mortgage, and was unjustly enriched by charging him a "convenience fee" to process his mortgage payment. PennyMac successfully moved to dismiss, establishing the mortgage did not bar charging the fee and it was not debt under the statute. *Cooper v. PennyMac Loan Services, LLC*, 509 F.
