

Student Housing Project: Provided comprehensive representation as local Florida counsel to the developers of a student housing project in Tallahassee. Closed the entire parcel assemblage, the construction loan, and, upon completion, the permanent refinancing transaction. Also assisted the client in closing each parcel of land and worked with the applicable lenders, surveyors, and title underwriters to complete all project transactions from start to finish.

**Build-to-Suit Commercial Projects**: Represents a commercial real estate development company in transactions involving build-to-suit commercial projects. The transactions involve the acquisition of land, including resolving title issues associated with the acquisition, working with lenders, providing title insurance, and handling the subsequent sale to purchasers of the developed project.
