### Notable Work

**Solar Energy Project Dispute:** Representation of owner/developer of an 11.5 megawatt solar energy generation multi-site project where a dispute arose with the EPC contractor over construction and performance issues. Negotiated a resolution of the client's claim of more than \$40 million through aggressive litigation techniques.
